The selection of positions shall be made in the order of the applications until the vacancies are exhausted.</p> <p>3. In the cases when the APPLICANT imports their furniture and/or equipment (hot and refrigerated display cases, stands, regalia, constructions, etc.) and declares the use of power supply with power over 200 W, they are obliged within 10 working days from submitting an application and booking a stand, to provide the organizer with a scheme of the placement of the equipment with the exact dimensions of each appliance or structure, as well as the technical specification of the appliances, indicating their maximum power in kW.</p> <p>If the APPLICANT does not fulfill the specified requirement, the organizer has the right to cancel the application and provide the stand to another company. If you wish for a change in the originally requested equipment and construction of stands, it is agreed with the organizer, no later than 10 working days before the date of the forum.</p> <p>4. Each APPLICANT is obliged to follow the program and the working hours of the forum. In case of violation of the time intervals for import of equipment and products on the day preceding the day of the event, the APPLICANT owes a penalty of BGN 100 without VAT for each started hour outside the specified ones.</p> <p>APPLICANTS are not allowed to leave the forum, as well as to export equipment and products before 4.15 pm on the day of the event. In case the APPLICANT or their representative violates this rule, the APPLICANT owes a penalty in the amount of the paid participation fee.</p> <p>5. In case of impossibility to hold the event, due to circumstances beyond the control of Patchwork Ltd., the latter refunds to the APPLICANT the full amount paid for participation.</p> <p>6. The parties to this contract shall not be liable for non-compliance with the agreed clauses caused by force majeure. Force majeure circumstances are considered to be such exceptional unforeseen circumstances and uncontrollable events, beyond the ability of the parties to foresee them, occurred after the signing of this Agreement, leading to an objective impossibility to fulfill the subject of this agreement. The lack of a green certificate or the morbidity of the representatives of an exhibiting company is not a force majeure circumstance and is not a ground for revoking the due penalty in case of refusal to participate. Any refusal to participate, based on force majeure circumstances, is considered justified only on the basis of a certificate of force majeure issued by the BCCI.</p> <p>7. In case of refusal to participate up to 60 days (19.02.2023 / 27.02.2023) before the date of the forum, the APPLICANT owes a penalty of 50% on the application filled in by them. In case of refusal to participate up to 30 days (19.03.2023 / 27.03.2023) before the date of the forum, the APPLICANT owes a penalty in the amount of the entire amount of the application filled in by them.</p> <p>8. The requested stands shall be paid within 10 working days from the date of the issued pro forma invoice, but not later than 5 days before the date of the event.</p>
